

CITY OF PORTAGE LA PRAIRIE
BY-LAW No. 07-8376

BEING A BY-LAW OF THE CITY OF PORTAGE LA PRAIRIE to provide for water and sewer rates and the collection thereof.

AND WHEREAS it is deemed advisable to amend the Water and Sewer Rate By-Law No. 06-8326;

AND WHEREAS it is deemed advisable to provide rates to be paid by persons to whom water is supplied by the City and who use the sewer system of the City and to provide for the collection thereof.

NOW THEREFORE THE COUNCIL OF THE CITY OF PORTAGE LA PRAIRIE, IN SESSION DULY ASSEMBLED, HEREBY ENACTS A BY-LAW AS FOLLOWS:

1. This By-Law shall amend By-Law No. 06-8326 with a new Schedule "A", Section 2 for 2008 water and sewer rates as attached hereto.
2. This By-Law shall have force and effect to all consumers supplied by the waterworks system except consumers exempted therefrom by Statute, by written agreement with the City of Portage la Prairie, or excepting any consumers expressly exempted from the operation of this By-Law by a By-Law of the Council of the City of Portage la Prairie.
3. Consumers shall pay for water and sewer service supplied to them by the City at rates and times set out in Schedule "A" attached hereto for 2008 and forming part of this By-Law.
4. This by-law and rates hereto shall come into full force and effect on the first day of January 2008.

Sewer only residential customers

For most customers, the average quarterly consumption in gallons of water used for residential customers at the domestic sewer rate plus the quarterly service charge.

Where an exception to this occurs there is a water meter installed at locations such as these and charged per quarter on measured consumption.

B) Water only customers

Quarterly minimum charge is the same for each meter size as shown in table above, except that the Sewer Commodity charge is excluded.

C) Sewer only residential customers

Customers using sewer service only will pay the relevant minimum charge shown in "A" above except that the water commodity charge will be omitted.
